## POLICIES

1. Registration fees are non-refundable
2. Tuition is calculated on the total number of weeks of dance and divided into monthly or instalment payments for convenience
3. Discounts cannot be combined and DDA staff will determine eligibility. Competitive programs are excluded from the discount programs.
4. Payments are to be made by the 10<sup>th</sup> of each month or late fees will be applied. Payment made between the 10<sup>th</sup> – 22<sup>nd</sup> of the month will incur a \$5 fee. Anything after the 22<sup>nd</sup> will be charged \$15.
5. Students with an overdue balance of more than 30 days will not be allowed to return to class until payment is made
6. Initial costume deposits (\$40 per costume) are due by Oct. 1<sup>st</sup>. A second deposit (\$40 per costume) is due by Dec. 1<sup>st</sup>. Any outstanding balances will be due upon pick up
7. Any classes missed by the student for any reason are not discounted, refunded, or credited. Students are able to take a make up class within 4 weeks of the original missed dates. Classes that are cancelled by the studio for any reason will be rescheduled at a time and date suitable for the instructors.

## REFUNDS/WITHDRAWALS

1. Costume deposits are non-refundable. Should a student withdraw after costumes have been purchased, account holders are responsible for all remaining costs associated with said costume.

2. Students who wish to withdraw from the program need to provide notice to DDA within 2 weeks of their withdrawal date. Refunds will only be given to those who have unused tuition weeks on their account (3 instalment payments only).
3. Monthly payments are non-refundable

### **ONLINE COURSES/PANDEMIC PREPARDNESS**

1. Should we be forced to shut down in a whole or partial government mandated closure, DDA in its sole discretion and without notice is entitled to provide its programs and training, exclusively through an online format.
2. Tuition will be reduced to 70% of your monthly or instalment payments should we move to an online format. You have the option to opt out of online classes.
3. Classes will continue to have the same instructor and students in each class and meet at the same time/date online via ZOOM.
4. Students who wish to opt out of online classes, will not be able to return to the same class in person, should we be allowed back into the studio after a short period of time. This is because students will continue to learn routines and technique as if they were attending in person classes.
